7. The Hirer should notify the owner within 24 hours after any breakdown, loss or damage of the Item.
8. The Hirer should provide flexible time and access to any property if required for the purpose of inspecting the conditions of returned Item(s).
9. Item(s) should not be taken out of UK without previous written consent from the Owner.
10. The Hirer is responsible of calibrating the Item, and supplying any consumables (i.e electricity voltage) accordingly.
11. Item(s) should be returned clean and with all relevant paperwork/documents attached.
12. The hirer must not repair or attempt to repair the Item without previous consent of the Owner.
